A PROPERLY COMPLETED AND SIGNED OFFICIAL ENTRY FORM MUST BE RECEIVED BY THE COLORADO TBF TREASURER ON OR BEFORE THE APPLICATION DEADLINE DATE OF **12:00 P.M. FRIDAY (MAY 7, 2021) TWO WEEKS PRIOR TO THE BEGINNING OF THE OFFICIAL PRACTICE DAY. ENTRIES RECEIVED AFTER THIS TIME WILL BE SUBJECT TO A \$25.00 LATE FEE AND MUST BE PAID IN CASH.**

The Tournament waters shall be off limits to all competitors commencing at 12:01 a.m., **May 17, 2021, MONDAY THE WEEK OF THE TOURNAMENT**, until safe light on the first practice day, May 20, 2021.

**Off Limits Area;** Spillway Bay will be the live release area and the only off limits area for the tournament. **Markers will be placed in the bay indicating the beginning of the off limits area.**

**Registration-Rules-Draw Meeting;** Friday May 21, 2021. Quality Inn, west parking lot. Pizzas provided, bring a chair and a drink.

**Contestants must be off the tournament waters by 2:00 p.m., ON FRIDAY May 21, 2021.**

Registration, 3:00 to 3:30 p.m.

Rules; 3:30 to 4:00 p.m.

Draw; 4:00 to 4:30 p.m.

Each TEAM or Team Representative (prior notification must be made to the Tournament Director) must check in with official Colorado TBF Tournament staff at the time and place prescribed on the schedule of events.

At the Pre-Tournament Check-In/Registration Teams will participate in order out draw.

IT SHALL BE EACH COMPETITOR'S RESPONSIBILITY TO CHECK THE SCHEDULE OF EVENTS FOR REGISTRATION TIME AND LOCATION OR OBTAIN THIS INFORMATION FROM THE TOURNAMENT DIRECTOR.

DURING THE OFFICIAL PRACTICE AND COMPETITION DAYS OF COLORADO T.B.F. Inc. TOURNAMENT, NO CONTESTANT MAY OPERATE A BOAT UNLESS THAT CONTESTANT HAS A MINIMUM OF \$300,000 BOATING LIABILITY INSURANCE. THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.

Only one may exceed 21 inches.

No culling or grading up.

This Tournament will qualify 6 teams for the 2021 Region 21 National Semi Finals.
