There are no off-limits to tournament waters prior to qualifying series events as they are one day events.

Off Limits Area: To be announced at the pre-tournament meeting.

Registration-Rules-Draw Meeting; Morning of tournaments. North Shore parking area. Each Team or Team Representative (prior notification must be made to the Tournament Director) must check in with official Colorado TBF Tournament staff at the time and place prescribed on the schedule of events. At the Pre-Tournament Check-In/Registration Teams will participate in order of draw.

THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.
